PER CURIAM:\*

Michael Dean Daniels challenges the imposition of the \$500 fine imposed by the district court as part of his sentences on the counts of conviction. Daniels failed to object to the fine in the district court. Therefore, we review for plain error. See United States v. Rodriguez, 15 F.3d 408, 414-16 (5th Cir. 1994).

In Rodriguez, we declined to exercise our discretion to review a challenge to a fine, a fine imposed under similar

circumstances as the case before us. For the reasons stated in Rodriguez, 15 F.3d at 416-17, we decline to exercise our discretion to consider the issue.
